Finance –

The Autumn Fest show had a profit \$4025.80; net income for October 2025 was \$6601.90.

A proposal from Gay McCann was received requesting an increase in pay due to the additional responsibilities associated with the organization becoming a 501c3. Laura Miller made motion to continue with Gay McCann as financial secretary. Cynthia Schuetz-Smith seconded; motion passed. Rebecca Miller made motion increase Gay McCann's monthly pay from \$125 to \$175, and ask that she take over contacting judges for the Amateurs (as she now does for open and youth). Cynthia Becca Schuetz-Smith seconded; motion passed.

Fundraising –

A total of \$860 was raised from the silent auction held at the Autumn Fest show in October.

So far, \$575 has been turned in for raffle tickets on the scooter (\$170 profit on the \$400 scooter). The drawing will be held at the Holiday Classic show in December. The pins for numbers will work for shirts, but not long enough for a show pad (modifications being tested).
