· Recommendation made by Rules Committee-

Effective 2020, any new class added to a MQHA sponsored show, to qualify for year-end high point award, the newly added class must have a sponsorship of at least \$1500.00 over a three-year trial period. The sponsor of the new class would be the official sponsor of said class for the three-year period. The sponsorship is to be paid as follows, \$1,000 before the show application is finalized and submitted for year one. The remaining \$500 is to be paid before the show application is finalized and submitted in year two. Of the first \$1,000 paid, \$500 goes to the Dixie National show, and \$500 would go to branch of the association that is responsible for the year end high point award for that class. Of the second \$500 paid, \$250 goes to the Dixie National show, and \$250 would go to branch of the association that is responsible for the year end high point award for that class. After the three-year period, the MQHA Awards Committee will review the new class along with all classes that receive high point year end awards to determine ongoing viability.

Motion made by Tom McBeath to accept the recommendation of the Rules Committee, seconded by Aprille Watts, motion passed.

 The Rules Committee, Show Committee and Awards Committee are to work together to determine whether we should add language to the MQHA Show Rules requiring a member to have to show in at least one MQHA, MQHYA or MAQHA sponsored show held in Mississippi to qualify for a year end award. This was tabled for further study. Motion made by Aprille Watts, seconded by Tom McBeath to post the minutes to the website after the minutes are approved. Motion passed.
